2. Approval of Previous 2018 EC and Post Congress EC Meeting Minutes Moscow

3. Relations with IOC

Following update presentation from Executive Director Tom Virgets, the Executive Committee has motioned to create a task force to investigate the letter distributed to IOC Sport Director and AIBA National Federations from suspected Kazakhstan organization. The task force composition will be announced in the coming weeks.
